1. INTRODUCTION

Shearing is a physical occupation with workers therefore at an increased risk of work-related injury and illness, so it is of critical importance for industry to improve safety standards. The Wool Industry needs to reduce the likelihood of injuries and accidents occurring in shearing sheds to increase entry, retention and longevity of staff, as well as industry productivity and profitability.

The Shearing Shed Safety Program aims to:

- Assist woolgrowers, shearing contractors and shed workers to assess their current shearing shed working conditions, environment and equipment;
- Provide employers with an understanding of their duty-of-care obligations;
- Help woolgrowers create an improvement program to comply with workplace standards;
- Make the workplace safer for all participants with health and safety as priorities for the wool industry by identifying safety hazards and providing options to control risk in the shearing shed.

This guide and assessment is not a compulsory standard, it has been developed in conjunction with industry to provide shearing shed operators with an understanding of the risks and options to control risks wherever possible. By planning and noting the improvements and steps to control risk, you will be able to provide direct evidence of your efforts in managing safety as required by Workplace Health and Safety Legislation in your State.

Action to improve health and safety in the industry is not only a responsible step to take in terms of human health; duty-of-care is a legislated responsibility under Work Health and Safety Acts and Regulations in each State. For all these reasons, it is good business sense to manage safety and reduce the high cost of injury.

This Program has been developed by Australian Wool Innovation (AWI) and the WA Shearing Industry Association (WASIA).

This document has four parts:

1. Legal obligations of people involved in shearing
2. Guidance on how to assess and manage risks by using this assessment guide
3. Detailed best practice guidance for all areas of shearing operations
4. Checklists
 - Full assessment for growers
 - Pre-Shearing checklist for contractors

2. THE LEGAL DUTIES OF PERSONS INVOLVED IN SHEARING

There are a number of entities that can be involved in the work of wool harvesting - the grower, the shearing contractor and the shed staff. Whilst all people involved in work in the shearing shed have a responsibility to identify hazards, the primary responsibility to ensure effective controls of risk are implemented lies with the person conducting the business or undertaking (PCBU) which includes the owner-manager or employer.

Employers or a Person Conducting a Business or Undertaking (PCBU) - woolgrowers, managers and shearing contractors - have responsibility for the safety of all workers (including shearers, shed hands, cooks, wool classers and wool pressers,

contractors and visitors). The duty-of-care of a woolgrower extends to contractors and their employees as though they were the woolgrower's employees.

If shearing contractors are used (e.g. shearing team), then there is a joint responsibility between the woolgrower/manager and the contractor as they employ the team members. The farm owner/manager and the contractor must work together with all workers to meet health and safety responsibilities. This extends to the workplace and all facilities and accommodation provided for employees.

The parties who have developed and supported this Shearing Shed Safety Program believe that the best way to reduce the high number of injuries that occur in and around shearing sheds is for all those who take part in wool harvesting to work together towards achieving a greater sense of safety all year round.

Code of Practice has been developed to provide practical guidance for persons who have duties to manage risks to health and safety under the WHS Act and Regulations applying in a jurisdiction. The duty is placed on persons conducting a business or undertaking, including employers, self-employed, principal contractors, persons with management or control of a workplace, designers, manufacturers, importers and suppliers of plant, substances or structures that are used for work.

3. USING THIS SHEARING SHED SAFETY GUIDE

This Shearing Shed Safety Program provides a structure to systematically identify and control risks in the shearing shed looking at:

1. The Shearing Shed
2. Machinery & Equipment
3. Amenities & Facilities
4. Work Practices
5. General Working Conditions

Steps in the Shed Safety Assessment Process

The Shed Safety Assessment Program is designed to engage the various stakeholders including the woolgrower, shearing contractor and shearing team members in a cooperative effort to improve safety in wool harvesting activities.

The process results in a prioritised improvement plan to control identified hazards and manage safety risks in a way which will prevent accidents, injuries and damage in the workplace.



Risk management process

1. Identify Hazards

Hazards are the jobs, activities, processes, materials, machines, buildings, equipment, facilities and work practices that have the potential to cause harm.

Use the Shearing Shed Safety Program and Checklist and conduct a “walk around the shed”, with other participants if applicable and identify all risks, take photos if relevant and make notes.

Think about any past safety and health incidents, problems and hazards that have not been addressed. Talk to workers in the shed who know a lot about the hazards and risks in a shearing shed and have experience in working in a wide range of sheds and conditions. This can be helpful in working out the best way to make improvements.

2. Assess the Risk Level

Assessing risks is about working out how likely it is that a hazard will cause harm. Use this Risk Matrix to assess the likelihood and severity of the risk to determine the overall Risk Level for each risk.

3. Control the Hazards & Manage the Risk

Once you have your list of hazards and their level of risk assessed and prioritised, the next step is to determine and implement the actions or “controls” you will take.

Any risks assessed must be eliminated as far as is practicable. If they can't be eliminated, look for alternatives that can be substituted to lessen the hazard to an acceptable level, then look for engineering solutions, administrative solutions

(policies and procedures) or implement the use of personal protective equipment that might help.

Risk controls that rely on workers doing things differently often don't work very well as they require constant supervision and training. Protective equipment is often uncomfortable or doesn't allow the worker to do their job properly and end up not being used.

STRATEGY	DESCRIPTION
ELIMINATION	Where reasonably practicable, hazards must be eliminated, or removed from the workplace. This is obviously the most effective way to reduce risk. While it is often not possible to eliminate a hazard, WHS regulations require employers use this option where reasonably practicable. If it is not possible, then the next most effective solution should be sought and put in place.
SUBSTITUTION	Replace with a safer alternative. Where it is not possible to eliminate a hazard altogether, consider whether the hazard can be substituted for something that will do the same job but is less risky.
ENGINEERING	In most hazardous situations it is possible and practicable to improve the design of work and/or isolate the worker from the hazard. This is the basis of many of the safety improvements that should be put in place to reduce the risk of injury as well as to be compliant with WHS regulations.
ADMINISTRATIVE	Administrative controls include Safe Operating Procedures or rules, organising work in such a way that reduces risk. It also includes giving safety induction and training to workers, supervising unskilled workers and providing safety information to workers about the safety risk associated with the work to be done and how these risks can be minimised.
PERSONAL PROTECTIVE EQUIPMENT (PPE)	Provide personal protective clothing and equipment where workers cannot be protected from a hazard by a control measure higher up the order. This is a last resort measure only.

4. Record, Monitor and Review

Monitor and review each control measure to ensure that the hazards have been eliminated and not caused new or different problems.

Retain a copy of any Improvement Plans, as it will be useful in discussions with your contractor and other key stakeholders. If a WorkSafe inspector should ever visit your shed, you may find this Improvement Plans useful in demonstrating the risk assessment processes and resulting actions that have been undertaken.

It is recommended that the grower, contractor and members of the shearing team, work through the checklists:

- At least annually
- Prior to and after each shearing event, and
- When systems are changed - ie when new equipment is purchased, facilities and/ or work practices are changed.

Using the Checklists

Before shearing starts it is recommended that employers meet with workers to discuss safety and health and resolve any particular safety and health matters that are raised.

The "Pre-Shearing Checklist" should be used to conduct a pre-work audit and reach agreement between the woolgrower, contractor and shed staff on how any issues found will be dealt with.

The "Induction" checklist should be used by the employer to induct the shearing team and ensure all important work practices are identified.

After shearing is also a very good time to use the Post-Shearing Checklist and record anything broken during shearing, or issues noticed during shearing. This allows time before the shearing teams are next in the shed to address issues.

Growers should use the Shearing Shed Safety Program and the Full Checklist with the 5 modules at least once a year, preferably early in the off-season to go through the shed and record all issues for resolution. This allows as much time as possible to make all changes and improvements before the next shearing.

MODULE 1 - THE SHEARING SHED





Safe access to and movement around the shed is essential and can reduce the risk of injury from trips, slips and falls. This may result in back injuries and fractures. Variations in floor levels may also place stress on the lower back and knees. The risk of knee, ankle and lower back injury increases when jumping off or stepping down from height.

1.1.1	<ul style="list-style-type: none"> The Shed Structure is sound and safe to enter, including shed frames, beams, flooring, roof and walls. 	
1.1.2	<p>Platforms</p> <ul style="list-style-type: none"> All platforms over 1000mm (1m) high have safety rails & gates or chain as suitable barriers. The edges of the platform and leading edges of steps are painted with a bright stripe to improve visibility. 	<ul style="list-style-type: none"> Consider installing rails or tight chains (fixed or removable) along the edge of raised platforms. Refer to the Australian Standard AS1657-2013, Fixed Platforms, Walkways, Stairways And Ladders – Design, Construction and Installation” 
1.1.3	<p>Step/Stairs</p> <ul style="list-style-type: none"> All steps and stairs are in good condition. ‘Steps’ should not be a ‘ladder’? Steps are securely fixed in place, non-slip, deep & wide enough to tread on safely. Steps are evenly spaced and not too high. Steps should not have a horizontal gap between them or a gap between the steps and the wall which could allow workers to step through the gap. 	<ul style="list-style-type: none"> Replace ‘ladders’ with fixed steps with extended handrail to 900 mm above the top floor. Ensure steps are level, secure and not slippery. Consider ‘scabbling’ timber steps. Repair/replace rotting, loose or broken steps. Install deeper steps or extra steps to make ‘step up’ shorter or to eliminate horizontal gaps. Extend steps to the wall to fill any gaps. 
1.1.4	<p>Handrails</p> <ul style="list-style-type: none"> Handrails are fixed to the outside of any steps. All handrails are strong and stable. There are no ‘finger traps’ in open end pipes. 	<ul style="list-style-type: none"> Install handrail on the outside of steps. Repair or make the handrail stable. Cover/fill open end of rail pipes. 

1.2 ACCESS TO AND MOVEMENT AROUND THE SHED		
1.2.1	<ul style="list-style-type: none"> The Shearing Safety Zone is adequate between stands, pens, shearing and wool handling (including room for left hand shearers). 	<ul style="list-style-type: none"> Relocate shearing plant to be at least 1525mm apart in older sheds and 2100mm apart in new sheds. Relocate other activities away from shearing area.
1.2.2	<ul style="list-style-type: none"> There must be sufficient space in the wool room to ensure there are no collisions and contact with machinery. 	<ul style="list-style-type: none"> There should be a minimum open space of 2000mm (2m) between the wool table and any machines. There should be a minimum open space of 1000mm (1m) around the wool press. Ensure the area between the wool table and shearing board is level and free of obstacles.
1.2.3	<ul style="list-style-type: none"> Work and traffic areas are uncrowded, free of obstructions and debris e.g. power cords are suspended and people, animals & clutter are minimised. Note: Legislation requires increased diligence in all workplaces to ensure that work areas remain clear of build up of debris and rubbish. 	<ul style="list-style-type: none"> Ensure an adequate work area exists to avoid overcrowding. All work areas and pathways are kept clear of debris, power leads, wool butts etc. Run power leads overhead and above head height to avoid trip hazards. Non-work materials do not clutter work areas.
1.3 FLOORING		
1.3.1	<ul style="list-style-type: none"> Floors & battens throughout the shed are sound and well maintained. Check for missing, rotting, warped, loose, slippery flooring or flooring made of high friction material (e.g. melwire). Check for protruding nails & screws. 	<ul style="list-style-type: none"> You should repair or replace broken battens / flooring. Melwire grating should be re-secured (e.g. if the melwire overlap is uneven and protruding upward). Secure loose and lifted platform boards.
1.3.2	<ul style="list-style-type: none"> Floors & battens throughout the shed are even, without steps or gaps for tripping hazards. 	<ul style="list-style-type: none"> Secure raised or warped battens to achieve a smooth walking surface. 1.3 FLOORING (CONTINUED)		
1.3.3	<ul style="list-style-type: none"> The floors must be dry & secure. 	<ul style="list-style-type: none"> Ensure all wet areas and spillage are mopped up.
1.3.4	<ul style="list-style-type: none"> Floors where a bale trolley is used are level and free of broken timber flooring. There are no large tin patches, sagging tin or raised edges. 	<ul style="list-style-type: none"> Chamfer raised edges to eliminate trip hazards. Replace all tin flooring with secure wooden flooring.
1.4 RAMPS & YARDING		
1.4.1	<ul style="list-style-type: none"> There is adequate overnight 'yarding' capacity for enough sheep to cover the following day's total tally. 	<ul style="list-style-type: none"> Consider options for increasing covered yarding capacity to meet daily requirements and consider covered external yards or a shed extension. Consult with the contractor regularly throughout shearing to ensure adequate supply of 'drained' sheep to keep pace with shearing. 
1.4.2	<ul style="list-style-type: none"> The sheep entry ramp is sound and without broken or rotting planks and battens.. 	<ul style="list-style-type: none"> Broken battens and boards are replaced. Loose boards are secured. Protruding screws are countersunk. Sharp metal is covered or turned in. Consider a concrete ramp. 
1.4.3	<ul style="list-style-type: none"> Loading doorways / raised platforms over 1000mm (1m) high has a closing door or gate for when not in use or an exclusion chain with signage. 	<ul style="list-style-type: none"> Install / Repair gate or door. Install a sign for the gate or door to remain closed when loading is not in progress. 

1.5 SHEEP PENS, RACES & GATES		
1.5.1	<ul style="list-style-type: none"> The design of races & pens promotes sheep to run and provides adequate flow. 	
1.5.2	<ul style="list-style-type: none"> Light does not come from under the floorboards and may hinder sheep from running. 	<ul style="list-style-type: none"> If light affects sheep movement, consider reducing light coming from below, either by extending the external shed to the ground or to lay the floor slats across the flow of sheep.
1.5.3	<ul style="list-style-type: none"> Sides of pens, races and gates are free of protrusions, sharp edges and splinters, posing hazards for workers. 	<ul style="list-style-type: none"> Round off any pointed corners. Remove protruding bale hooks or wires. Re-weld broken and protruding melwire. Cover or turn-in sharp metal edges.
1.5.4	<ul style="list-style-type: none"> Gates are made of lightweight material. 	<ul style="list-style-type: none"> Consider replacing heavy and sagging timber gates with lightweight, slide and swing or lift & swing gates.

1.5 SHEEP PENS, RACES & GATES (CONTINUED)		
1.5.6	<ul style="list-style-type: none"> Gate catches and stops in penning up area operate easily and are easy to operate one-handed. 	<ul style="list-style-type: none"> Consider options for one-handed gate catches.
1.5.7	<ul style="list-style-type: none"> 'Telescoping' Gates are a safety risk. 	<ul style="list-style-type: none"> Telescoping gates should be removed or made into 'swing and slide' gates as they are a safety risk. 
1.6 CATCHING PENS, GATEWAYS & DOORS		
<p>The impact of catching pen and gateway design can influence the risk of injury. The physical size of the pens may result in excessive lifting and dragging of sheep if they are too large or restrict maneuverability if too small. The size, weight and action of the catching pen doors have injury implications. Low doors can strike the shearer in the lower back when pushed backwards by a sheep. Heavy doors can also induce back pain and strain when they strike the shearer as they drag the sheep from the pen. Gates which have a high level of resistance and hinges that do not swing freely may also contribute to increased fatigue and back strain while dragging. The shearer should be able to walk backwards from the catching pen door to the downtube without needing to twist or turn more than 90°. The best design is where the shearer walks backwards to the shearing position through a smaller angle.</p>		
1.6.1	<ul style="list-style-type: none"> The size of the catching pen does not require excessive lifting and dragging to operate. 	<ul style="list-style-type: none"> Catching pen size should be 2100mm wide x 3050mm deep (7ft x 10ft) and no less than 1830mm (6ft) wide and no more than 3200mm (10.5ft) deep.
1.6.2	<ul style="list-style-type: none"> Chutes that protrude into catching pens are guarded to prevent trip hazards for the shearer during tip & drag operations. 	<ul style="list-style-type: none"> Install a rail guarded with rounded corners or board off around the chutes inside the catching pens. 
1.6.3	<ul style="list-style-type: none"> There is one catching pen available for each shearer. 	<ul style="list-style-type: none"> Separate or re-design catching pens to achieve one pen per shearer. Locate doors for proper positioning ie forward of the shearing stand. Another example is where the catching pen and door directly face the stand so the door is at an angle to the wall rather than parallel with it.
1.6.4	<p>Catching Pen to Down Tube Alignment & Distance:</p> <ul style="list-style-type: none"> The alignment and distance does not require the shearer to turn more than 90 degrees for both left and right handed shearing. The drag distance from the back of the catching pen to the downtube should be kept to a minimum eg no more than 3005mm (3.05m). 	<ul style="list-style-type: none"> Re-align catching pen doors with shearing stand to avoid forward drag of sheep ie where the shearer has to drag forward of the catching pen door to the shearing position. Consider options to limit drag distance from catching pen to shearing position. The distance from the back of the catching pen to the downtube should be no more than 3005mm (3.05m).

1.6 **CATCHING PENS, GATEWAYS & DOORS (CONTINUED)**

1.6.5 **Equipment/Tool Benches:**

- An equipment/tool bench is available for each shearer.
- The equipment/tool benches are adequately sized (not less than 300 x 600mm), stable and located inappropriately.



Tool benches need to:

- be level
- be not less than 300 x 600mm
- have raised edges
- be positioned out of the work area e.g above let out pens or behind shearing plant poles, not on board side.



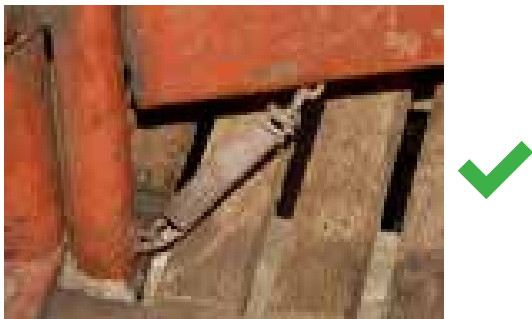
1.6.6 **Flooring:**

- Battens should run towards the catching pen gates.
- Battens are made of appropriate material (not melwire) to limit surface drag that increases risk to shearers.
- The flooring is in good condition, with no rotten or loose battens.
- There should not be a step or obstruction between the catching pen and the board eg board fixed to the floor across the gateway.

- Consider options for turning battens to run toward the catching pen gate.
- Consider replacing melwire with battens or other smooth surface material.
- A gradual floor slope in the catching pen toward the shearing board of 75mm for every 2500mm (2.5m) will assist with the ease of drag.
- Ensure the floor is clear of obstructions.

1.6.7 **Catching Pen Doors:**




- The top edge of the pen door should not be able to strike the shearer in the lower back.
- The doors are self-closing and close completely & automatically with each use.
- The doors swing in both directions (optional based on shearer preference).
- The doors are smooth and free of protrusions on both sides.
- The doors do not have pinch points.






'Best Practice' includes:




- self-closing doors (close completely automatically and not be wired or propped open)
- double doors (consider narrower door nearest the shearer)
- double-action hinges, fixed with 'flush' fittings
- light-weight (e.g. 'forming ply')
- rounded corners
- maintain hinge adjustment & springs to ensure doors close completely
- gates that swing both ways
- If possible have a 15mm gap between the doors where they meet.

Sufficient space is required in the wool room to enable the fleece wool to be safely and effectively skirted and classed. There is a risk of a range of injuries due to collision with fellow workers and contact with shed machinery - influenced by the amount of space available. A well designed and constructed wool table is essential for safe work and reduced risk of strain and injury.

- Replace protruding foot brace at front edge of wool bins with a low-profile fastener or post into the floor.

- Best practice are wool handling trolleys which are wider and backward inclining. Do not use warehouse trolleys which are upright and maybe too narrow.

- The routes between wool bins and press should be short and clear of obstructions.

MODULE 2 - MACHINERY & EQUIPMENT

In sheds operating equipment such as grinders, shearing plant and wool presses incorrect positioning, installation and poor maintenance can hinder safe access and result in significant injury. Ensure all equipment is located away from thoroughfares and traffic. Wherever possible upgrade to equipment that has the latest in safety mechanisms. Before shearing starts, ensure all machinery is checked and working correctly. All electrical leads must be in good condition and positioned safely. The owner of the equipment is responsible for ensuring it is in good working order and all users should check and verify this before using.

Providing appropriate amenities is a key responsibility of the owner/ manager. The influence of amenities and living conditions on the ability of workers to complete their duties safely and effectively cannot be underestimated.

Providing appropriate amenities is a key responsibility of the owner/ manager. The influence of amenities and living conditions on the ability of workers to complete their duties safely and effectively cannot be underestimated.

5.4.3	Action is taken to limit ammonia from stock urine in the shed. Consider installing a commercial fan to improve ventilation if build up is occurring.

5.5 DISEASES FROM ANIMALS (ZONOSSES)

Zoonoses are serious diseases that humans catch from animals and they can be life-threatening. Working in a shearing shed and handling animals all day exposes shed workers to infection. Infections may include Q Fever, hydatid infection, Leptospirosis, Orf and Yolk boils and wool sorters' diseases/wool lung. Cuts, scratches and grazes which may eventuate from crutching and shearing are a common target for infection. Sources of infection may include sheep urine and manure, maggots, lice, and a range of veterinary and agricultural chemicals.

5.5.1	<ul style="list-style-type: none"> Work practices are in place to limit worker exposure to infection. 	<ul style="list-style-type: none"> Encourage all workers to be vaccinated against Q Fever. Sheep with an active outbreak of orf must not be shorn or crutched until their condition is resolved. Use proper safeguards when handling infected animals.
5.5.2	<ul style="list-style-type: none"> Good sanitary amenities are provided and maintained that promote good hygiene practices 	<ul style="list-style-type: none"> Provide a hand wash basin with soap and water. 5.6 LIGHTING

Low lighting or glare can increase the risk of slips, trips and falls for workers and cuts to the shearer. Excessive glare or poor lighting levels may place extra strain on the eyesight of shed workers resulting in headaches, fatigue and decreased work capacity. The Australian Standard for lighting in wool sheds specifies a minimum light level of 400 lux (about that found in a well lit kitchen).

5.6.1	<ul style="list-style-type: none"> All lights work and lighting is adequate for general movement and work, especially in the main work areas e.g stands, wool handling & pressing. 	<ul style="list-style-type: none"> Balance internal light with bright external light e.g. increase internal lighting or reduce external light penetration e.g. blinds. Hearing damage (Noise Induced Hearing Loss or NIHL) is a typical injury associated with agricultural production where workers are exposed to loud noise.

Long hours of exposure and relatively loud levels of noise in the shearing shed should be minimised where possible. The maximum noise level of 8 hours a day is 85dB. As a guide if it is difficult to have a normal conversation at a distance of 1m there may be a noise problem. To properly assess noise risks it may be necessary to measure noise exposure. From Safe Work Australia see "[Model Code of Practice: Managing noise and preventing hearing loss at work](#)".⁸

SAFE SHEDS - THE SHEARING SHED SAFETY PROGRAM



Making the wool harvesting workplace safer for all.

1. HOW TO USE CHECKLISTS

Safe Sheds, The Shearing Shed Safety Program provides four checklists to use at different times of the shearing season:

Full Assessment Checklist

Growers should use the best practice guide and the full checklist with the five modules at least once a year, preferably early in the off-season to go through the shed and record all issues for resolution. This allows as much time as possible to make all changes and improvements before the next shearing.

Pre-Shearing Checklist

This checklist should be used by a woolgrower and the shearing contractor prior to shearing commencing to assess the safety of the shearing shed and reach agreement between the woolgrower, contractor and shed staff on how any issues found will be dealt with.

Induction Checklist

Used by the employer with the shearing team to ensure all important work practices are identified and that all shed staff are aware of work practices and safety information.

Post Shearing Checklist

This checklist should be used by a woolgrower and the shearing contractor immediately after shearing to report any issues noticed or items broken or damaged during shearing. This allows time before the shearing teams are next in the shed to address issues.

2. FULL ASSESSMENT CHECKLIST

This checklist should be used by a woolgrower to assess the safety of the shearing shed(s) on the property.

It is recommended that this be done at least once a year in the off-season to allow enough time to make improvements before shearing commences.
